- \* **OUT OF TOWN BUSINESSES:** \$215.00
- \* **SUBSIDIARY MEMBERSHIP** (Companies with same owner, same name, different location in Dyer County):  
# of total Employees at all locations + \$50 for each location. Only one rep per location; main location receives new member discounts.
- \* **AFFILIATE MEMBERSHIP** (Companies with same owner, different names, same location in Dyer County):  
# of full time employees at both companies + \$125.00 for second business.
- \* **INDIVIDUAL MEMBERSHIP:** \$85.00  
Persons not actively participating in a business or profession, retired persons, individual who work for a member firm and wishes an individual membership within that firm. **No voting privileges.**
- \* **NON-PROFIT MEMBERSHIPS:** \$100.00  
Churches, government employees or agencies, community clubs and organizations.
- \* **COLLEGES/UNIVERSITIES/SCHOOL SYSTEMS:** \$200.00
- \* **PROFESSIONALS:** \$250.00  
Includes one professional + \$75.00 for each additional full time professional or \$45.00 for each part-time professional.  
*Professionals include but not limited to: Physicians, Nurse Practitioners, Health Groups, Dentists, Attorneys, Engineers, Accountants, Chiropractors, Orthodontists, Optometrists, Pharmacists, Financial Advisors, etc.*
- \* **REAL ESTATE/INSURANCE:** \$250.00  
Includes one principal agent + \$35.00 for each broker/agent, independent contractor or associate within the firm.  
*Real Estate Agents: All brokers must join to get the discounted rate -or- if all real estate agents do not join under the firm membership, they may purchase their own membership at \$85.00 per year.*
- \* **RESTAURANTS:** \$215.00 + plus .75 per seat over 50 seats.
- \* **MOTELS/HOTELS/ASSISTED LIVING/APARTMENTS:** \$215.00 or \$5.00 per room - whichever is greater.
- \* **FINANCIAL INSTITUTIONS:** \$50.00 per million deposits - Dyer County Only.
- \* **HOSPITALS:** \$250.00 or number of employees - whichever is greater.
